About Carla House School

Carla House School is owned by Care4Children, a company providing education, care and therapy. Pupils who attend the school are resident in the on-site children's home. The school provides education for a maximum of five girls aged 11 to 18 years with a range of social, emotional, and behavioural needs. Currently, there are three pupils on roll.

The school is situated in a rural area near Wrexham. There is one large classroom and a smaller room used for music, individual sessions and therapy.

There is a lead teacher and one additional teacher. The work of the school is overseen by a regional head of education.

Main findings

Strengths

Pupils make suitable progress towards their individual goals and participate well in their learning. They engage enthusiastically with the interesting range of learning activities offered by the school. These include creating a large wall collage, rowing and music making.

Staff carry out effective initial assessments on all pupils. This enables them to understand the gaps in their knowledge and understanding. Teaching activities are adapted creatively to reflect the interest of pupils, such as the use of rowing to teach about angles.

Teaching and care staff work together highly effectively. They provide pupils with a stable and secure environment. As a result of their consistent caring approach, over time pupils learn to build positive relationships with staff. In addition, pupils attend the school regularly which is a significant improvement from their previous disengagement from education.

Weekly meetings between the regional head of education and all lead teachers support effective communication across the organisation. There is appropriate professional development of staff. For example, through training on trauma informed practice, delivered by a clinical psychologist.

The school has appropriate processes for self-evaluation which link well to school improvement priorities.

Recommended areas for action

Increase opportunities for pupils to experience vocational training, outdoor pursuits, drama and the creative arts, and prepare for the world of work.

Ensure placing authorities provide comprehensive information about pupils' educational abilities.
